



It is the policy of Orthopedic Institute not to discriminate on the basis of race, color, national origin, sex, age or disability. Orthopedic Institute has adopted an internal grievance procedure providing for prompt and equitable resolution of complaints alleging any action prohibited by Section 1557 of the Affordable Care Act (42 U.S.C. § 18116) and its implementing regulations at 45 C.F.R. pt. 92, issued by the U.S. Department of Health and Human Services. Section 1557 prohibits discrimination on the basis of race, color, national origin, sex, age or disability in certain health programs and activities. Section 1557 and its implementing regulations may be examined in the office of Mary White, 810 East 23rd St., Sioux Falls, SD 57105, 605-331-5890 who has been designated to coordinate the efforts of Orthopedic Institute to comply with Section 1557.

Any person who believes someone has been subjected to discrimination on the basis of race, color, national origin, sex, age or disability may file a grievance under this procedure. It is against the law for Orthopedic Institute to retaliate against anyone who opposes discrimination, files a grievance, or participates in the investigation of a grievance.

Orthopedic Institute complies with applicable Federal civil rights laws and does not discriminate on the basis of race, color, national origin, age, disability, or sex.
